SCHEDULE OF WINTER MARKETS: One market per month on the third Saturday of the month: November 21, December 19, January 16, February 20, March 20, April 17.

MARKET LOCATION: Ringwood Park and Ride, near the bus shelter

MARKET HOURS: 10am-12pm, rain or shine

MARKET EQUIPMENT: No tents required; signs and prices required as usual.

MANAGEMENT: Market will be managed by board volunteer.

MARKETING: Monthly email blasts will be sent to mailing lists. Vendors are encouraged to develop their own customer mailing lists and to take orders as they wish. Posters will be placed in town. Backpack e-flyers will go to school children monthly. Leaflets with winter season schedule will be distributed during October, and two ads will run in the Suburban Trends and West Milford Aim with dates and time of the markets. There will also be a sign at the end of Cannici Drive the week prior to the market.

BOOTH FEES: \$10 per 10' X 10' booth, per market day. \$60 per full winter market season. Fees cover advertising costs. Double booths are permitted at \$20 per market day.

FEE SCHEDULE: All fees for the full winter market season are due by October 31, 2009. Any Regular Season Vendor with an outstanding balance due to Eat Local is not eligible for winter market until balance is settled completely.
